- In order to claim such a refund, on or before the 180th calendar day after the original scheduled embarkation, please submit a copy of the boarding pass, proof of payment (and amount), and a copy of the cancellation or delay notice by email to GeneralInquiries@Seabourn.com if you booked your cruise directly with Seabourn or to your trip advisor if you booked your cruise through a trip advisor. You may also contact us at 1-800-442-4448 (Monday through Friday from 6 a.m to 5 p.m. (Pacific Time), and from 7 a.m. to 3:30 p.m. (Pacific Time) on Saturday). Seabourn will review the refund request and respond by email within 180 days of the date the claim is made.
